I certify that I am physically fit and have not been advised to not participate by a qualified medical professional. I certify that there are no health-related reasons or problems which preclude my participation in this activity or event. I realize that the failure to disclose such information could result in harm to fellow participants and me. I agree to notify Willow Haven Outdoor should there be any change in my health status prior to participating in any event.

I agree to indemnify and forever hold harmless THE FOLLOWING ENTITIES OR PERSONS: Tadpole Investment Properties, LLC DBA Willow Haven Outdoor (hereinafter referred to as TP-WHO) and/or their directors, officers, employees, volunteers, representatives, and agents, the activity or event holders, activity or event sponsors, activity or event volunteers; from and against any and all claims, liabilities, and causes of action, whether foreseeable or unforeseeable, which may at any time arise out of or relate in any manner, directly or indirectly, to my: (i) negligent acts or omissions; (ii) participation in any event operated by TP-WHO; or (iii) failure to disclose any relevant health information.

I want to participate in a Survival Course offered by TP-WHO. I acknowledge that taking this course and participating in the activities sponsored by TP-WHO will require some skill, training and equipment for which I am solely responsible, and I know that all types of bodily injury and disability are a risk to participating in these activities.
